



Self declaration of the suitability and non-existence of exclusion grounds acc to §§ 123 and 124 GWB (Act against Restraints of Competition)

The certificate number of the prequalification database for the supply and service sector (PQ VOL) can replace the self declaration. All required proofs and declarations, which are not listed into the database, must be submitted with the tender.

I. Details of the payment of taxes, duties and contributions to the statutory social insurance

I / We declare that I / we have fulfilled our obligation to pay taxes and duties as well as the contributions to statutory social security insofar as they are subject to the obligation to pay contributions.

II. Information on insolvency proceedings and liquidation

I / We declare that an insolvency proceeding or a comparable statutory procedure has not been applied for or opened, a request for opening has not been rejected due to lack of funds and my company is not in liquidation.

III. Indication that no serious fault has been committed which jeopardizes the applicant's reliability

I / We declare that no serious fault has been committed which cast doubt on my/our reliability as a candidate, for instance by an effective prohibition of occupation (§ 70 criminal code (StGB)), an effective provisional prohibition of occupation (§ 132a criminal code (StGB)) and that no final verdict within the last Two years against me / us or employees with management tasks because of

Forming criminal organisations (§ 129 criminal code (StGB)), Forming terrorist organisations (§ 129a criminal code (StGB)), Criminal and terrorist organisations abroad; extended confiscation and deprivation (§ 129b criminal code (Criminal code (StGB))), Terrorism financing (§ 89c Criminal code (StGB)), Money laundering; hiding unlawfully obtained financial benefits (§ 261 Criminal code (StGB)), Fraud (§ 263 Criminal code (StGB)), Subsidy fraud (§ 264 Criminal code (StGB)), Taking and giving bribes in commercial practice (§ 299 Criminal code (StGB)), Bribing delegates (§ 108e Criminal code (StGB)), Giving bribes and Giving bribes as an incentive to the recipient's violating his official duties (§ 333 und § 334 Criminal code (StGB), also in conjunction with foreign and international staff (§ 335a Criminal code (StGB))), Bribery of Foreign Public Officials in International Business Transactions (Section 2 of Article 2 of the Act on Combating International Bribery), Human trafficking for the purpose of sexual exploitation, Human trafficking for the purpose of work exploitation, forced prostitution, forced labour, Exploitation taking advantage of a deprivation of liberty (§§ 232, 232a section 1 until 5, §§ 232b until 233a Criminal code criminal code (StGB))

which was punished with imprisonment for more than 3 months or a fine of more than 90 daily rates.

IV. I / We declare (s) that I / we have not been convicted in the last two years for the infringement of regulations resulting in an entry in the commercial register, with imprisonment for more than 3 months or a fine of more than 90 daily rates or a fine of more than € 2,500.
